Instructions following removal of teeth

What should I do when I get home?

- To help reduce the swelling, apply a covered ice pack or a cold towel to the outside of your face in the area of the extraction during the first 12 hours.
- You may require some painkillers. Take these as instructed and regularly for the first three days and then as required.

DO

- Keep the extraction site as clean as possible.
- When resting, keep your head raised above the level of your heart.
- Have only lukewarm liquids and soft food for the rest of the day and do not suck through a straw or you may dislodge the clot.
- Starting the following day rinse your mouth with a warm, salty mouthwash, consisting of 1 teaspoonful of salt dissolved in a glass of hot water. Used frequently this can promote healing and prevent infection.
- If bleeding starts after you get home, sit down and apply firm pressure over the area for at least 20 minutes by biting firmly on a rolled-up swab or clean handkerchief. If bleeding persists, contact the maxillofacial department or if out of hours the Accident and Emergency department for further advice.
- If you are prescribed any medication by the doctors do take the full course as instructed.

DON'T

- Do not brush your teeth for the first 8 hours after surgery. After this, you must brush your teeth as normal, being very careful around the area of surgery.
- Avoid eating and hot drinks while your lips and tongue are numb, or you may accidentally bite or burn them.
- Avoid smoking for 72 hours following surgery as this can cause infection or pain. We recommend that you use a nicotine patch during this period.
- Do not drink alcohol for the remainder of the day as this could induce bleeding.
- Avoid strenuous exercise for the first few days as this may initiate bleeding.
- Do not rinse your mouth for the rest of the day.

Antibiotics:

- If prescribed take the complete course as instructed. If you have any adverse effects, stop taking them and contact your GP or the MFU department who will be pleased to help.
- If you are taking the Oral contraceptive pill, any antibiotics may reduce the effectiveness and you should use an additional form of contraception for the remainder of the cycle

Will I have to come back to hospital?

Most patients do not need to come back to the hospital for a follow-up appointment.

When can I return to work/college?

It depends on the person, the type of procedure and the type of job or study you do. Most people need at least two days off. It is important to remember you will not be able to drive or operate machinery for 48 hours after having a general anaesthetic.
