# Routine pregnancy testing before treatment for Females aged 12 years and over

### Why do I have to be tested?

It is very important that we do not carry out any procedure on a young woman who may be pregnant. This is because it may be harmful to either the young woman or her unborn baby. If we know about a pregnancy we may be able to do the procedure in a different way that avoids these risks.

## What happens next?

We will need to ask you some questions. These questions can feel embarrassing so you may want to talk to the nurse in private without your parents being there. You should be offered this option. We will need to ask you if you have started your periods, when was your last one and if there is any possibility that you might be pregnant. This will mean asking you if you have had sex and we have to ask this as some girls begin this sort of relationship with boys earlier than others.

We will then ask you if it is OK for us to test a sample of your urine (wee). For most girls the result will be negative meaning you are not pregnant and the operation or procedure will go ahead.

You may then be asked to give your consent for a pregnancy test. If we do not feel that you fully understand then we may ask your parent/guardian. You will then be asked to provide a sample of urine which will then be tested. If the result is negative you will be told.

If the test is positive which means you are pregnant we will then need to talk further to you about what may need to happen next. It may mean that the procedure will be postponed to another time.

## Do my parents have to know if the test is positive?

Not necessarily. We would encourage you to discuss this with your parents but if you don't want this we have to respect your privacy in both agreeing to the test and giving you the result if we assess you as "competent". This is a legal term which means you understand all of the issues and can make an informed decision. We will then help to support you and give you whatever information you require with regard to the pregnancy and next steps.

## Can I refuse to have the test?

Yes you can but we would want to discuss the reasons why so that we could make the best decisions on how to proceed with your care and keep you safe. If we feel that you may not understand enough about this decision then we may ask your parent. It may mean that your procedure is postponed or delayed.

### Who can I talk to if I want more information?

You can talk to your doctor if you feel comfortable doing this or you could ask to speak to a nurse either at your out patient clinic or when you arrive at the hospital for your procedure.
