East Sussex Healthcare NHS Trust do not have any CCTV in the café. However, 53.3° North Coffee Company may have their own stand-alone system.

Copy of your CCTV policy.

Whilst the Trust holds the information requested, it is applying a Section 31(1)a exemption because disclosure of this information under the Act would, or would be likely to, prejudice the prevention or detection of crime.

The Trust considers that the release of our CCTV policy would make the Trust more vulnerable to crime as it could put the organisation, staff and patients at risk of theft, harm and terrorist activities by highlighting our level of security.

In applying the exemption consideration has been given to the public interest in enabling scrutiny of public sector decision making and the general public interest in accountability and transparency.

In this instance, we consider that the public interest in preventing the prejudice outweighs the public interest in disclosure due to the significant impact a successful criminal/terrorist attack can have.
