I am responding to your request for information under the Freedom of Information Act. The answers to your specific questions are as follows:

- 1) How many cancer operations have been cancelled by your NHS Trust in each of the past four financial years: 2022/23, 2021/22, 2020/21 and 2019/20.
- 2) Please could you provide a breakdown for the reasons these operations were cancelled - e.g. lack of staff, lack of beds, or equipment issues, again broken down by the financial years 2022/23, 2021/22, 2020/21 and 2019/20.

If possible please can you provide this information in a spreadsheet.

Subsequent to your initial request you forwarded the following clarification:

To clarify following my request below, I am looking for information on cancer operations that were cancelled on the same day, and for non-clinical reasons.

By cancer operations, I am referring to procedures being undergone by cancer patients as part of their treatment for the illness.
