I am responding to your request for information under the Freedom of Information Act. The answers to your specific questions are as follows:

Information requested:

1) The total number and spend of nursing shifts sent to agencies to fill (frameworks and off frameworks).

August – 1905 shifts sent to agencies. September – 1909 shifts sent to agencies.

Note there is only an ESHT spend on Nursing agencies once the shifts have been filled. Theres is no spend at the time the shifts are requested.

Please provide these totals separately for August and September 2023.

2) The total number and spend of nursing shifts filled by agencies (frameworks and off frameworks).

August – 755 shifts filled. September – 843 shifts filled.
