The information you have requested, in respect of spend, is exempt under section 41 of the Freedom of Information Act 2000. This is because the information would originally have been provided in confidence. Information is exempt information if —

- (a) it was obtained by the public authority from any other person (including another public authority), and,
- (b) the disclosure of the information to the public (otherwise than under this Act) by the public authority holding it would constitute a breach of confidence actionable by that or any other person.

Whilst the Trust holds the information requested, it is applying a Section 43(2) exemption in relation to the spend as the release of the information is likely to prejudice its commercial interests.

In applying the exemption consideration has been given to the public interest in enabling scrutiny of public sector decision making and the general public interest in accountability and transparency.

We have concluded that sharing commercials could disadvantage the supplier against their competitors and may leave the Trust open to a legal challenge.

In this instance, we consider that the public interest in withholding the information is greater than the public interest in disclosing the information.

2) Do you manage your payroll in-house or do you outsource it if so, who do you outsource it to?

Outsourced to Sussex Health & Care Payroll Hub, run by NHS Shared Business Services (SBS).
