Section 17 Notice of Refusal

East Sussex Healthcare NHS Trust does not centrally record the cause for allergic reactions/ anaphylactic shock. To enable the Trust to provide this information would require a manual review of individual patient notes which we estimate would take hundreds of hours due to the number of cases. We are therefore applying Section 12(1) to this part of your request.

Section 12(1) of the Act allows a public authority to refuse to comply with a request for information if the authority estimates that the cost of compliance would exceed the 'appropriate limit', as defined by the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 (the Regulations). These state that this cost limit is £450 for public authorities which are not part of central government or the armed forces. The costs are calculated at £25 per hour per person regardless of the rate of pay, which means that the limit will be exceeded if the work involved would exceed 18 hours. The Trust estimates that the cost of complying with this request would significantly exceed the above limit.

The Trust estimates that the cost of complying with this request would exceed the above limit based on the estimate that the time taken to retrieve this information from each record on average being 5 minutes and there being 4243 records to check resulting in the region of 350 hours of work.

7. How many of these cases in questions 5 and 6 related to children under 18? For Q5 we have indicated the number related to children under 18 within the table We are unable to provide the data for Q6 so are not able to answer this question.
