1. How many injuries that resulted in accident and emergency department visits to your trust were caused by Gardening? 2122

The total 2122 includes only the number recorded in our systems between Dec 2020 and Dec 2023. Prior to Dec 2020 there are no records held. In addition, the records only capture a portion of possible injuries caused by Gardening. The “cause” field is not mandatory and has many other options.

2. How many of those injured were male? 938
