I am responding to your request for information under the Freedom of Information Act. The answers to your specific questions are as follows:

This request is in relation to the use of social value weighting of 10 per cent in your procurement of goods and services, which has been mandated by government for NHS Trusts and Foundation Trusts since April 2022.

- 4. How much in total have you spent in procurement on local business/organisations, each financial year, since April 2022? Please including your definition of a local business/organisation, if you have one.

East Sussex Healthcare NHS Trust does not centrally record the amount spent in procurement on local business/organisations. We can confirm there are 595 local suppliers within the Trust's supplier database. To enable the Trust to provide the information requested, 595 manual queries would need to be run, downloaded and analysed, which we estimate would take approximately 49 hours. We are therefore applying Section 12(1) to this part of your request.

Section 12(1) of the Act allows a public authority to refuse to comply with a request for information if the authority estimates that the cost of compliance would exceed the 'appropriate limit', as defined by the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 (the Regulations). These state that this cost limit is £450 for public authorities which are not part of central government or the armed forces. The costs are calculated at £25 per hour per person regardless of the rate of pay, which means that the limit will be exceeded if the work involved would exceed 18 hours. The Trust estimates that the cost of complying with this request would significantly exceed the above limit.

5. How much have you spent on SMEs each FY since April 2022? The government defines an SME as a company with fewer than 250 employees, turnover under €50m and balance sheet under €43. If the trust has a different definition then please provide it.

Clarification was sought asking you to advise what GBP values we should use for question 5: Turnover Under ?? GBP, Balance Sheet Under ?? GBP and confirmation was received as follows:

I am not in a position to determine how you define and SME. I used the government definition as an example that I felt trusts may use when recording data on your procurements. If this is the definition you use, then you need to set the GBP values to those you use when categorising procurements as with an SME or a large organisation.

If you do not use the government definition, please send it to me alongside the figures I requested broken down using your own definition.

If you do not use any definition of an SME when categorising the entity you're contracting with then please say so.

We do not hold this information as we do not hold information for our suppliers relating to their turnover or number of employees.

6. How much have you spent on VCSEs each FY since April 2022? Again, please include your definition of a VCSE if you have one.

Clarification was sought with regard to your definition of VCSE and confirmation was received as follows:

A VCSE is a voluntary, community and social enterprise. It is a commonly used term to describe charities, public service mutuals, and social enterprises.
