I am responding to your request for information under the Freedom of Information Act. The answers to your specific questions are as follows:

1) Please provide the number of incidents recorded in 2021, 2022, 2023, and 2024 that are classified under the following codes or descriptions: ICD-10 5th Edition:

Clarification was sought with regard to if you are only interested in falls related to 'ice/snow' – not other types of falls, and confirmation was received that you are only interested in falls related to 'ice/snow'.

If ICD-10 is not used, then ICD-11 codes:

If neither ICD-10 nor ICD-11 codes are used:

a) The number of incidents where slipping or falling on/off ice or snow was mentioned.

For Each Relevant Incident, Where Possible, Please Include:

- a) A breakdown by year/month.
- b) A breakdown by age.
- c) A breakdown by gender.
- d) A brief description of the injuries sustained.

Please note that whilst I can confirm that we hold the information in relation to the age of the patient, due to the low numbers, we are not prepared to disclose this information as the patient could be identified and this would breach the principles of the Data Protection. I am therefore applying a section 40(2) exemption under the Freedom of Information Act 2000 – Personal Information of third parties. However, we have provided the age range for each patient instead.
