As part of our ongoing work to better understand the delivery and effectiveness of Acute Kidney Injury (AKI) services across healthcare organisations, we are seeking information on the current AKI services and practices within your organisation.

No, we do not have a formal AKI bundle that is used within the organisation. However, as part of the induction process all resident Doctors receive training and education on how to recognise and manage AKI. They are also provided with a Resident Doctor Digital Handbook that has guidance on the management and recognition of AKI. All blood results are alerted within our Pathology System (Clinysis ICE) if an AKI is present.
