## FREEDOM OF INFORMATION ACT

I am responding to your request for information under the Freedom of Information Act. The answers to your specific questions are as follows:

I would like to request the following information regarding equality, diversity, and inclusion (DE&I) within East Sussex NHS Trust:

1) How many equality, diversity, and inclusion (DE&I) roles are currently employed within East Sussex NHS Trust?

Clarification was sought asking you to confirm if you want to know the number of staff within the Trust that are responsible for DE&I for Trust staff or patients or both and confirmation was received that you require both.

There are two people employed within the People Engagement team whose focus is on equality, diversity, and inclusion and look after the workforce only.

2) What is the total cost of these roles, including salaries, pension contributions and NI contributions and any necessary direct administrative support?

Total cost for the 2 roles linked to our workforce only - £134,762.

## 3) What is the number and cost of external training bodies and courses related to DE&I training?

Education Supervisor Refresher Training (half-day) – one of the topics covered in this workshop touches upon DE&I with reference to on-going support of our resident doctors and Locally Employed Doctors / International Medical Graduate Doctors. Course is 3-yearly and mandatory. Four sessions were run in 2023/24. Delivered by MacGuire Training at around £2,500.00 per workshop.

We support Deaf Awareness- one off cost – Health Education England funded Diversity in Health and Care Partners Programme 2023/24 £1800.

## 4) What specific DE&I initiatives have been undertaken by the trust in the past three years, and what has been the associated cost of these initiatives?

Unconscious Bias workshops –  $14 \times 3$ -hour workshop sessions delivered in <u>2021-22</u>. Open to doctors, nurses and Allied Health Professionals (AHP) member of staff. Total cost was £15,740.00. Funding received as the result of a successful Health Education England bid.
