## FREEDOM OF INFORMATION ACT

I am responding to your request for information under the Freedom of Information Act. The answers to your specific questions are as follows:

I am submitting this request under the Freedom of Information Act 2000 to obtain data on NHS treatment of complications arising from surgical procedures performed overseas.

East Sussex Healthcare NHS Trust does not record whether treatment of a patient is as a result of complications arising from surgical procedures performed overseas. There is no subject code for this type of procedure to be reported on within our Trust systems. Any treatment would be recorded as the presenting symptom such as infection, bruising or swelling for example. To enable the Trust to provide the information requested would require a manual review of the medical notes of every individual that attended A&E from January 2020 to January 2025 with any number of associated conditions. As this would require the review of hundreds of thousands of patient records this would take significantly over 18 hours. We are therefore applying Section 12(1) to your request.

Section 12(1) of the Act allows a public authority to refuse to comply with a request for information if the authority estimates that the cost of compliance would exceed the 'appropriate limit', as defined by the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 (the Regulations). These state that this cost limit is £450 for public authorities which are not part of central government or the armed forces. The costs are calculated at £25 per hour per person regardless of the rate of pay, which means that the limit will be exceeded if the work involved would exceed 18 hours. The Trust estimates that the cost of complying with this request would significantly exceed the above limit.

- f. Y60-Y69 Surgical errors and misadventures (e.g., accidental punctures, foreign objects left inside patients, failure of sterile precautions, inappropriate procedures).
- g. Y70-Y79 Medical devices associated with adverse incidents.
- h. Y83-Y84 Abnormal patient reactions or complications following surgery or other medical procedures.
