## FREEDOM OF INFORMATION ACT

I am responding to your request for information under the Freedom of Information Act. The answers to your specific questions are as follows:

1) For the financial years 2022/23, 2023/24 and current YTD, how many referrals have you received for wet AMD, diabetic macular oedema and retinal vein occlusion (Anti VEGf services) or perhaps referred to as medical retina?

We do not hold this information, as it is not recorded by the Trust.

2) For the financial years 2022/23, 2023/24 and current YTD, how many referrals have you rejected as unsuitable or undeliverable by your Trust?

3) For the financial years 2022/23, 2023/24 and current YTD, how many referrals have you received, triaged, booked and completed first assessment and treatment within the 2 week RTT advised by NICE and the college of ophthalmologists? - 6) Which drugs are your preferred for a new patient? Which drugs do you still use for follow-up patients?
  - New patients receive Vabysmo for AMD.
  - For diabetic patients the Trust uses Vabysmo and Eylea.
  - For Retina Vein Occlusion the Trust uses Eylea and will consider Vabysmo soon as it recently received NICE approval.
  - For follow-up patients the Trust uses Eylea and switches to Vabysmo where clinically indicated. There is very limited use of Lucentis.
- 7) Does your trust follow a see and treat "one stop" clinic format?

The Trust currently has a 'two-stop' clinic.

## 8) Does your trust follow treat and extend protocols where clinically appropriate?

The Trust follows the "treat and extend" strategy for new AMD patients. For Diabetic Macular Oedema and Retinal Vein Occlusion, the Trust follows the "Pro Re Nata" strategy, but is planning to move to "treat and extend" as soon as the Trust has the proper setting for this.

## 9) How many patients have you certificated as sight impaired or severely sight impaired in the FYs 2022/23, 2023/24 and year to date due to Wet AMD?

The information provided below is for patients where Wet AMD is listed in one or both eyes.
