FREEDOM OF INFORMATION ACT

I am responding to your request for information under the Freedom of Information Act. The answers to your specific questions are as follows:

Please note the following regarding the responses below:

- The readings are taken from a continuous formaldehyde meter. This equipment takes snapshot readings from approximately 1000 to 6000 times per day. The readings are, therefore, not specific to any particular event and will show multiple readings from the same time period where a fluctuation in levels occurred.
- At the Conquest Hospital site, the tissue processors are situated in the same location. This is the main reason for differing readings cross-site. To caveat this, staff are provided with formaldehyde masks while working in this area.
- The Formaldemeter itself will sound the alarm if the readings breach 2ppm; staff are instructed to leave the area is this occurs. Of the 69 readings in excess of 2ppm, 25 (36%) of these were outside working hours, so no staff would have been present.
