For questions 1-3. You can use the following codes: Primary Immunodeficiency D80 (Immunodeficiency with predominantly antibody defects)

Secondary Immunodeficiency as D84.81 (Immunodeficiency due to conditions classified elsewhere), D84.821 (Immunodeficiency due to drugs), and D84.822 (Immunodeficiency due to external causes). "Immunodeficiency, unspecified" is D84.9

Chronic inflammatory demyelinating polyradiculoneuropathy G61.8 Other inflammatory polyneuropathies
